1. What Are Cookies?

Cookies are small text files stored on your device (computer, smartphone, or tablet) when you visit websites. They help websites remember your preferences, login details, and browsing behavior to improve your user experience.

2. Types of Cookies We Use

We use the following types of cookies on our Website:

- a. Strictly Necessary Cookies

These are essential for the Website to function properly. Without these cookies, services like user authentication and secure areas of the Website will not work.

Example: Session cookies for login verification.

Legal Basis: Legitimate interest.

- b. Performance Cookies

These collect information about how you use our Website (e.g., pages visited, errors encountered) to improve its performance.

Example: Google Analytics (anonymized).

Legal Basis: Consent.

- c. Functionality Cookies

These allow the Website to remember choices you make (such as language preferences or location) to provide a more personalized experience.

Example: Remembering user settings.

Legal Basis: Consent.

- d. Targeting/Advertising Cookies

These cookies track your browsing habits and are used to deliver advertisements relevant to you. They may be set through our site by our advertising partners.

Example: Facebook Pixel, Google Ads.

Legal Basis: Consent.

3. How We Use Cookies

We use cookies for the following purposes:

- To provide and maintain the functionality of our Website.
- To improve user experience and performance.
- To conduct analytics and track website usage.
- To personalize content and ads.
- To remember user preferences and settings.

4. Third-Party Cookies

Some cookies may be placed on your device by third-party services we use, such as:

- Google Analytics
- Facebook Pixel
- LinkedIn Insights
- Hotjar / Microsoft Clarity (if used)

These third parties have their own privacy and cookie policies. We recommend reviewing them for more information.

5. Managing Cookies

You can control and manage cookies in your browser settings. You may:

- Delete stored cookies;
- Block all cookies;
- Allow only specific websites to set cookies;
- Disable third-party cookies.

Note: Disabling cookies may affect your experience on our Website.
